Settlement concerning three works by Anton Romako, »Akt eines jungen Mädchens« (LM 499), »Die Quelle« (LM 496) and »Nike mit Kranz« (LM 91) with the legal heir of Dr. Oskar Reichel.

The Leopold Museum Private Foundation is able to announce that, following strenuous efforts, negotiations with the only living heir of Dr. Oskar Reichel have reached a favorable conclusion, with the Leopold Museum Private Foundation voluntarily agreeing to pay a financial settlement.

The Leopold Museum is delighted that yet another settlement has been reached. Both the Board of Directors of the foundation and the legal representative of the heir call this settlement a »fair and just solution«.
